Dam bill aims to ensure public safety

Editor, Times-Dispatch:

In response to the recent letter, "Dam bill seeks to profit engineers," concerning the dam safety bill (SB 1060) that was passed by the Virginia Senate: James E. Atkins inferred the purpose of the bill was to enrich and benefit engineers and no one else. The Virginia Society of Professional Engineers (VSPE) feels Atkins' comments are misguided.

The bill applies to dams greater than 25 feet in height or that have 50 acre feet of stored water behind the dam. Most small farm ponds are below this threshold. The bill was introduced by Hanover County, and VSPE worked with Hanover and the State Dam Safety Department to find a reasonable balance between cost and public safety. This is an important issue. In the past 15 years there have been significant dam failures in Williamsburg, Fairfax and Lynchburg. On June 22, 1995, privately owned, operated, and maintained Timber Lake Dam failed, resulting in two fatalities. Even when there is no loss of life or property values, there are still impacts to wildlife and the environment.

Professional engineers are licensed by the state. Our role is to protect the health, safety and welfare of the public in conjunction with our designs and work projects. We apply this concept to all infrastructure: roads, public water, buildings, bridges, dams, etc. Requiring a dam to be inspected at least once every six years is a reasonable measure to ensure protection of those downstream. It's similar to getting a checkup from your doctor every six years. Early detection is the key to preventing more costly repairs or replacements.

With this in mind, VSPE reviews all legislation affecting the engineering profession to find a reasonable process that offers protection to public health and safety while balancing risk and costs.
