And of that rather impressive sum, "\$31.6 m the last five years for which financial data is available (2005-2009)."

That "denial machine" is a network of think tanks and front groups, many of which receive funding from other fossil fu dedicated themselves in part to convincing the public (and the public officials it elects) that climate change isn't real. like the Cato Institute and organizations like the Heritage foundation, which have strong ties to media outlets and, of conservative politicians. And the Koch brothers -- each of whom are tied for fifth wealthiest man in America -- fund th

Of course they do: they call for the elimination of environment-protecting laws that are a pain in the Kochs' ass. As (Brad Johnson at the Wonk Room comes to mind), the Kochs' operations are as pollution-heavy as you can imagine refining, coal power plants, industrial manufacturing, etc -- these are its most profitable undertakings. It makes perfec and nail to shut them down. Unfortunately, while doing so may save them some cash (as if they need it), it screws ov polluted air, drink contaminated water, live in a warmer world, and so on

Another way the Kochs use their money to buy influence is by funding the Americans for Prosperity -- it's the primary founded it. They were major supporters in the movement to overturn California's clean energy and climate law, a national politics. And, unsurprisingly, one of their chief goals is to prevent climate action. Of the eleven freshman Senators who publicly question settled climate science, ten received funding from Koch I

them signed the Americans for Prosperity "No Climate Tax Pledge" to obstruct policy solutions to climate change Representatives who deny climate science, 22 received Koch PAC funding in 2010, and all 38 signed the AFP pl

All this goes even further to reveal the extent of the Kochs' influence on the national political process, and illustrates power serve as a major obstruction to climate action.
