

This Week in Washington IP: Technologies for Military Readiness, Enforcing IP Rights in China and Alternative Dispute Resolution for Copyright Small Claims

October 19, 2020

This week in Washington IP events, the House of Representatives remains quiet during its district work period. Thursday's Senate Judiciary Committee hearing will focus mainly on the nomination of Amy Coney Barrett to serve as a Supreme Court Justice, although the day's discussion will include a bill introduced by Sen. Lindsay Graham to create an alternative dispute resolution pathway for copyright small claims. Many policy institutes, including Cato Institute, Hudson Institute and the Center for Strategic & International Studies, will host hearings focused on incorporating emerging technologies into U.S. military capabilities for future wartime readiness. The U.S. Patent and Trademark Office will also host an event to discuss government resources for business owners who want to protect their IP rights while operating in the Chinese market.

Information Technology and Military Power

In the book *Information Technology and Military Power* by Jon Lindsay, history shows that nations with technological dominance in military capabilities still struggle on the battlefield without a strong sense of what Lindsay calls "information practice," activities by soldiers involving the actual implementation of the technology in combat. This event will explore how the complexity of military technologies during the information age make it more crucial to address "information practice" to prevent struggles that the U.S. military has historically faced against weaker adversaries. International Security at the Nuclear Nexus (Day 1)

Issues related to nuclear technologies, both in weapons capabilities and energy generation systems, create sensitive national security concerns that cut across a large number of sectors of government activity. These sensitive concerns are amplified by the adoption of new technologies like artificial technology and machine learning and the risks posed by threats to cybersecurity. The first day of this two-day event will begin with opening remarks from Admiral Charles Richard, Commander, USSTRATCOM. Following those remarks will be a series of discussion panels focusing on topics including conventional-nuclear integration, or the use of nuclear weapons in conventional war against a nuclear-armed adversary; the weaponization of space and nuclear risks; and finally surveillance and situational awareness.

On Thursday morning, the Senate Judiciary Committee to consider a series of nominations for district court judgeships as well as the nomination of Amy Coney Barrett to serve as an Associate Justice on the U.S. Supreme Court. While Judge Barrett's nomination will undoubtedly receive the most focus during the hearing, the Committee will also discuss <u>S. 4632</u>, the Online Content Policy Modernization Act recently introduced by Senator Lindsay Graham (R-SC). If enacted, this bill would amend Title 17 of U.S. Code to establish an alternative dispute resolution program for copyright small claims, as well as amend the Communications Act of 1934 to modify the scope of civil liability protections for "Good Samaritan" blocking of offensive material online.
