

### Latest bulling and school violence survey shows South Dakota students need child safety accounts

The Centers for Disease Control and Prevention (CDC) has released the <u>2019 results</u> of their biennial Youth Risk Behavior Surveillance System (YRBSS), and the responses show public schools in the Mount Rushmore State are having a tough time keeping children safe.

The latest data from YRBSS shows over one in five South Dakota high school students, 21.2 percent, were bullied on school property in 2019, while another 16.1 percent of state high school students reported being cyberbullied.

Another 6.1 percent of South Dakota high school students reported being in a physical fight on school property in 2019, with 8.1 percent reported being threatened or injured with a weapon on school property. Disturbingly, 7.1 percent of state high school students reported skipping school at least once in the last 30 days due to concerns for their safety. Even more disturbingly, almost one in four South Dakota high school students, 23.1 percent, said they had seriously considered attempting suicide, while 12.3 percent reported actually attempting it.

The federal Every Student Succeeds Act (ESSA) permits students to transfer to another public school under ESSA's Unsafe School Choice Option provision, but only if their current public school meets the state definition of a "persistently dangerous" school. Because states define unsafe schools so narrowly, fewer than 50 American public schools out of nearly 100,000 are labeled "persistently dangerous" each year.

Students should not have to wait years at a time or become victims of violent crime before their parents are allowed to transfer them to safer schools, which is current policy. That is why The Heartland Institute is proposing for states to create a Child Safety Account (CSA) program. CSAs are a type of education savings account (ESA) program for parents who feel, for whatever reason, their child's school is unsafe. A CSA would empower parents to transfer their children immediately to the safe schools of their choice within or beyond their designated public school districts—including public district, charter, and virtual schools—as well as private and parochial schools. CSA funds could also be used to pay for homeschooling expenses.

Under Heartland's CSA program, students would be eligible for a CSA account if their parents had a "reasonable apprehension" for their children's physical or emotional safety, including bullying, hazing, or harassment. Parents could also determine their child's school isn't safe after reviewing the incidents-based statistics schools would be required to report.

Research shows students at private schools are <u>less likely</u> than their public school peers to experience problems such as alcohol abuse, bullying, drug use, fighting, gang activity, racial

tension, theft, vandalism, and weapon-based threats. There is also a <u>strong causal link</u> suggesting private school choice programs, such as CSAs, improve the mental health of participating students.

<u>Copious other empirical research</u> on school choice programs finds they offer families improved access to high-quality schools that meet their children's unique needs and circumstances. Moreover, these programs improve access to schools that deliver quality education <u>inexpensively</u>. Additionally, these programs <u>benefit public school students</u> and taxpayers by increasing competition, <u>decreasing segregation</u>, and <u>improving civic values and practices</u>.

An <u>annual survey</u> by Phi Delta Kappa reveals more than one-third of American parents fear for their child's safety at school. This number rises to 48 percent for parents earning less than \$50,000 per year. This represents a large jump from 2013, when only 12 percent of respondents answered they feared for their child's safety.

The South Dakota public education system's failure to protect children and provide parents with reasonable alternatives is precisely why this CSA program is so desperately needed. Every South Dakota family should have the opportunity to remove their child from an unsafe school environment. With Child Safety Accounts, this would become reality.

In this Heartland Policy Brief, Vicki Alger, senior fellow at the Independent Women's Forum and research fellow at the Independent Institute, and Heartland Policy Analyst Tim Benson detail the prevalence of bullying, harassment, and assault taking place in America's public schools and the difficulties for parents in having their child moved from a school that is unsafe for them. This report from the National Center for Education Statistics covers topics such as victimization, teacher injury, bullying and electronic bullying, school conditions, fights, weapons, availability and student use of drugs and alcohol, student perceptions of personal safety at school, and criminal incidents at postsecondary institutions. Indicators of crime and safety are compared across different population subgroups and over time. Data on crimes that occur away from school are offered as a point of comparison, when available.

#### The Effects of School Choice on Mental Health

This study from Corey DeAngelis at the Cato Institute and Angela K. Dills of Western Carolina University empirically examines the relationship between school choice and mental health. It finds that states adopting broad-based voucher programs and charter schools witness declines in

adolescent suicides and suggests that private schooling reduces the number of times individuals are seen for mental health issues.

This *Policy Analysis* from the Cato Institute examines the effect increased access to private schooling has had on international student test scores in 52 countries.
