### **CABINET:**

The Department of Environmental Protection is scheduled to give the governor and Cabinet a rundown on the state's land holdings. The presentation comes as a growing number of lawmakers and state agencies including the Department of Agriculture, the Florida Fish and Wildlife Conservation Commission and DEP say the state should consider selling off some parcels to private interests - which would presumably in many cases develop the sites - in order to purchase more strategic tracts. The panel will also review a proposal by the Department of Highway Safety and Motor Vehicles, which is seeking approval for a redesigned license plate. The Cabinet will also hear from Enterprise Florida on job growth and approve some rule changes regarding the administration of the Florida Retirement System. (9 a.m., Cabinet Room, The Capitol.)

# **PSC DIALS UP TELECOM FIGHT:**

The Florida Public Service Commission will start hearing arguments in a dispute between Qwest Communications Co. and other telecommunications firms about what are known as "intrastate switched access services," which are an important part of being able to complete long-distance calls. #### MEDICALLY NEEDY CHANGES DISCUSSED:

The state Agency for Health Care Administration and the Medical Care Advisory Committee will host a meeting about planned changes to the Medically Needy program, which provides coverage to people who have debilitating medical conditions but do not qualify for Medicaid. The changes are part of an overhaul of the Medicaid system that lawmakers approved in 2011. (1 p.m., Agency for Health Care Administration, 2727 Mahan Dr., Tallahassee.)
