Who Funds The Cato Institute?

Corporate structure, funding, and tax status are factors to consider. To comply with U.S. tax law, Cato Institute organizations are 501(c)(3). The Internal Revenue Code is responsible for taxation. Most of the institute's revenue is derived from private contributions, and it does not get government funding for this purpose.

(Koch Industries) is a leading industrialist in the world. Weiser & Company Inc. ranks second among U.S.-based private companies in terms of annual sales, following the conglomerate of more than twenty companies with revenues of \$115. As a global company, Koch employs roughly 60,000 US workers, "about 60,000 of whom are employed here."

Do The Koch Brothers Own Procter & Gamble?

Koch – which owns dozens of obscure businesses – could become a consumer and retail powerhouse, battling name brands like Procter & Gamble and others. Owned by Charles and David Koch, two of the four brothers of the Koch family, as well as other family members, associates, and friends, the company is a publicly traded corporation.

What Products Are Made By The Koch Brothers?

- A few examples: Georgia-Pacific is the country's largest plywood manufacturer; most of the papers used in their production are owned by the company.

Is Georgia-Pacific Owned By Koch Brothers?

Georgia-Pacific was acquired by Koch in 2005 for about \$21 billion. Georgia-Pacific's balance sheet was covered by a loan from Koch as part of its purchase.
