RED STATES RESTRICTING ABORTION COVERAGE IN EXCHANGES —

Conservative states may have lost their best chance to get rid of Obamacare, but they're winning the battle on another front: abortion coverage. States were explicitly given the authority to restrict abortion coverage in the health care law — it was a key provision that helped deliver enough votes to pass the ACA. Now, even some state legislatures turning their backs on exchanges are still passing legislation blocking abortion coverage in the new insurance markets. At least 20 states now ban or restrict the coverage of abortion procedures in exchanges, and some go even further to restrict it in all private insurance plans, too. - W.H. ADVISER: NO MORE MEDICAID CUTS One of President Barack Obama's top economic advisers addressed health care advocates yesterday, but his message was really targeted at states weighing the Medicaid expansion. That message: Obama won't support Medicaid cuts for the rest of his presidency. "Other than the most minimal, smart, efficiency type of measure, Medicaid savings, Medicaid cuts for this president, for this administration are not on the table," said Gene Sperling, director of the National Economic Council, at the Families USA conference in Washington yesterday. So, states should go ahead and expand, he said, "with the understanding that the rug will not be pulled out from underneath them." - --ADVOCATES ARE STOKED Both the National Association of Public Hospitals and Health Systems and Planned Parenthood put out statements yesterday cheering Sperling's Medicaid comments. "This is welcome news for the millions of people who rely on the safety net for essential health care services, for their communities and for the hospitals and health systems committed to their care," NAPH President and CEO Bruce Siegel said in a statement.

WAITING ON BASIC HEALTH? KEEP WAITING — CMS's Cindy Mann on Thursday put a damper on any hopes of states setting up a Basic Health Plan before 2014. Responding to a question about the plan's regulations (or lack thereof) at the Families USA conference, Mann said: "We have prioritized other areas of the law, and as you all know there aren't Basic Health Plans rules and regulations out yet. What we have been doing, particularly with some of the states that have been thinking about or most interested in potentially using the Basic Health Plan, is to think about some other

opportunities they might have to address the issues that they were looking to the Basic Health Plan to deal with," such as continuity of coverage.

BUNDLED PAYMENT DEMO IS UNDERWAY — CMS announced yesterday that 32 awardees from 10 New Jersey health care organizations would start testing bundled payments for acute care hospital stays by April. They're participating in Model 1 of the Bundled Payments for Care Improvement initiative. CMS also announced that it had selected 100 participants to work with 400 health care organizations for Models 2-4 that would begin receiving data from CMS on care patterns and consulting with the agency on care improvement. They would begin participating in bundled payments for different episodes of care as early as July. Last fall, CMS had said that it was holding off on Model 1 because the program had drawn less interest than hoped. No longer. The announcement: http://lusa.gov/WDf6tZ. SCOTT'S BUDGET DOESN'T ANSWER MEDICAID QUESTION — Florida Gov. Rick Scott gave his major budget speech yesterday, but he punted on one of the biggest budget questions facing the state — whether to expand Medicaid. "Today is not the day for that decision," Scott said, explaining that he's waiting on HHS to respond to two Medicaid waiver requests. "Their action on these two waivers will affect our current Medicaid program and play an important role in how we move forward."

N.C. GOVERNOR: NO RUSH ON EXPANSION — North Carolina Gov. Pat McCrory isn't offering his opinion on the ACA's Medicaid expansion, even as the state Senate is making quick work of a bill to block it in the state, The Associated Press reports. But it also doesn't sound like the new Republican governor is in a rush to expand. He says a new report from the state auditor identifies structural problems in the Medicaid program that should be addressed before the state can consider expansion. The AP

SENATE DEMS TAKE AIM AT BIG TOBACCO — Some companies have been repackaging roll-your-own cigarette products as pipe tobacco to take advantage of a twist in the tax law that favors certain non-cigarette tobacco products. Yesterday, Sens. Dick Durbin, Frank Lautenberg and Richard Blumenthal introduced the Tobacco Tax Equity Act, which would make sure those products were taxed as heavily as cigarettes so companies would not be able to provide cheaper products, particularly to kids. In

addition to the public health concern, the bill has another thing going for it. It's a moneymaker, to the tune of \$3.6 billion over 10 years, according to the Joint Committee on Taxation. Durbin's release: http://l.usa.gov/UH56zv
