

Latest GOP brainchild: An individual mandate ... for immigrants - Former Obama aide pitching insurers for ACA enrollment help - SCOTUS cold shoulder on abortion suit leaves battle to the states

LATEST GOP BRAINCHILD: AN INDIVIDUAL MANDATE ... FOR IMMIGRANTS — A funny thing happened on the way to immigration reform: Republicans started promoting an individual mandate. But don't confuse it with *the* individual mandate — the Obamacare requirement that most Americans obtain health insurance or face a penalty. Republicans are pushing that same concept but only for undocumented immigrants. Per Pro's David Nather: "The Republicans and other conservatives say their rule wouldn't be like Obamacare's at all. Their argument: It's simply fair to ask immigrants to show they won't be a drain on the system before getting full citizenship." But that argument presents a clear problem: it's the same logic that backers of Obamacare used to justify the health law's insurance requirement: if people are forced to get insured, they won't strain taxpayers by showing up at the emergency room as often.

--Cue the conservative bellyaching: "That is virtually the opposite of the main point they made against Obamacare," said Alex Nowrasteh of the Cato Institute ... "It's totally reasonable to make sure you don't expand the welfare state, but there's no need to do that by imposing a discredited, Obama-style individual mandate." http://politico.pro/143WAel

FORMER OBAMA AIDE PITCHING INSURERS FOR ACA ENROLLMENT HELP—Nancy-Ann DeParle, an architect of the Affordable Care Act and former aide to President Barack Obama, is leaning on insurers for millions of dollars to support Obamacare enrollment. Per Pro's Jennifer Haberkorn and Brett Norman: "Now in the private sector, DeParle is asking top executives at several health insurance companies to donate \$1 million or more to Enroll America, a nonprofit organization promoting Obamacare enrollment, several sources familiar with her role said." TODAY: HEARING ON OBAMACARE MANDATE PENALTIES — The Treasury and the IRS (cue the ominous music) hosts a meeting today on what kind of penalties will be levied when people fail to obtain insurance that meets minimum coverage standards required in the health care law. The 10 a.m. meeting is scheduled to be held at the IRS's headquarters at 1111 Constitution Ave.

SCOTUS COLD SHOULDER ON ABORTION SUIT LEAVES BATTLE TO THE STATES — Anti-abortion state lawmakers will have to put their thinking caps on to work around a decision by the high court that upholds an Appeals Court ruling prohibiting Indiana from defunding Planned Parenthood. The move by the Supreme Court is likely to touch off another wave of more targeted anti-abortion legislation meant to block Planned Parenthood from funding abortion services without violating the spirit of the Indiana decision. Pro's Kathryn Smith reports: "In letting the ruling stand, the high court avoids touching on that and the many other ways states can defund groups that provide abortions. State lawmakers who oppose abortion rights still 'have a lot of different tools in their arsenal to attack family planning providers that also do abortion,' said Elizabeth Nash, state issues manager at the Guttmacher Institute, which supports abortion rights." http://politico.pro/11nw9hU

--Meanwhile, the Republican standard-bearer for Virginia governor distanced himself Tuesday from suggestions that Planned Parenthood has been as deadly to the black community as white supremacists. But POLITICO's Emily Schultheis peels back the onion to find that Cuccinelli has espoused similar, albeit less inflammatory, rhetoric to suggest Planned Parenthood has racist roots. "In a 2011 speech to the Virginia Christian Alliance, Cuccinelli made reference to Planned Parenthood founder Margaret Sanger, who's sometimes accused of racist motivations for building clinics in low-income and black areas of the country ... 'I would also encourage you to pull out the map of Virginia. Look at where the abortion clinics are. Go look at that,' he continued. 'That doesn't make you mad? Well you're a lot calmer person than I am.'"http://politi.co/13gb3VU

E&C STAFF UNVEIL SGR REFORM FRAMEWORK — Medicare providers would have the option to opt out of the programs' existing fee-for-service framework under a draft SGR reform circulated Tuesday by House Energy and Commerce Committee staff. The framework, which will be the subject of a June 5 hearing, would scrap the existing Medicare physician payment formula in favor of an "improved fee for service system" that offers providers a chance to opt out in favor of "new ways of delivering care." But the big battle, how to pay for the revised formula, is the true test for the proposal's prospects — and the committee draft doesn't come with a proposal. Comments on the plan are due by June 10. AP: JUST ONE INSURER PLANS OFFERING ON N.H. EXCHANGE – That insurer? Anthem Blue Cross/Blue Shield, which said last week that it was the only carrier to propose a plan, according to the Associated Press. Perhaps it's a New England thing, suggested one industry expert. Caroline Pearson, vice president of the health consulting company Avalere Health, told the AP that Vermont's exchange is expected to feature two carriers, while Rhode Island will have two carriers in the individual exchange and three in the small group exchange.http://bit.ly/Zql3P1

ELDER ADVOCATES JOIN FORCES — The American Health Care Association and the Alliance for Quality Nursing Home Care announced plans to merge, creating a larger, more forceful voice for elder and long-term care issues. The consolidation is expected to be completed by July 1, and the group will retain the name American Health Care Association. "The economic straits our profession faces necessitated this union. We have heard the call of our members, and we have responded," said Mark Parkinson, AHCA president and CEO.
