

# Did Richard Hanna plagiarize the CATO Institute?

A recent story on NBC News' First Read website examines the issue of whether U.S. Rep. Richard Hanna, R-Barneveld, plagiarized the CATO Institute for a commentary on the Patriot Act he submitted to the Syracuse Post-Standard.

The story shows that both Hanna and <u>Julian Sanchez</u> of the CATO Institute used the terms "lone wolf" and "tangible thing" in making very similar points about the Patriot Act.

It's certainly an interesting topic considering that the campaign of nowformer U.S. Rep. Michael Arcuri, D-Utica, often tried to tie Hanna to the CATO Institute and that Hanna denied a true connection to the group when I asked him about it.

#### This is what I wrote in October for an Election Ad Watch:

"A May 15, 2008, biography of Hanna on WKTV's website addresses whether Hanna is a member of the CATO Institute:

'He is a sustaining member of the CATO Institute, having traveled to Russia as part of an international study group,' the WKTV story says of Hanna.

But in September this year, Hanna told the O-D he had been officially considered a member of the Cato Institute only because he subscribed to the organization's newsletter. He used to read the newsletter but doesn't buy into all of the institute's ideas, and he no longer subscribes to it. he said.'
