The Rise and Fall of the New York Times

What does the state of the "newspaper of record" tell us about the state of American journalism?

The New York Times, once seen as the gold standard in American journalism and the most trusted news organization in the country, is spiraling into irrelevance. A harbinger of the Times' demise: circulation has decreased sharply over the past two years.

What is killing the Times? Ideological bias or the Internet?

William McGowan argues in "Gray Lady Down: What the Decline and Fall of the New York Times Means for America" that liberal bias combined with Sulzberger's ownership incompetence is leading to the downfall of the once mighty media empire.

For McGowan, the *Times'* complete misreading of the Tea Party movement and embrace of Obama's vacuous hope-and-change campaign message are indicative of a warped worldview. Such arrogance and blind political bias are also to blame for the troubles of even the most revered newspapers.

Furthermore, the *Times* and other newspapers face a larger economic problem. Why pay for news? These days, you can access everything in the deadwood edition of the *Times* online and for free.

Indeed, print is a dying medium for accessing breaking news as readers demand more multimedia and more instant content. That said, there will always be a market for a good newspaper—even if it comes only in electronic form.

In this highly volatile media environment, the *Times* will have to change its strategy in order to stay afloat.

The fate of the *Times* could portend the fate of journalism as we know it.
