# Indiana lawmakers OK nation's most sweeping school voucher plan



In a major victory for Republican Gov. Mitch Daniels, Indiana lawmakers today approved legislation that <u>creates the nation's most sweeping system of taxpayer</u> funding for private schools.

The voucher plan, a cornerstone of Daniels' education overhaul, cleared the Republican-controlled House, 55-43. Lawmakers also approved a bill to ease and expand creation of charter schools.

The Associated Press writes that the new voucher system "would allow even middle-class families to use taxpayer money to send their children to private schools." Voucher programs are normally limited to disadvantaged families.

The Evansville Courier & Press has details of the plan.

*Education Week* points to <u>an analysis by the libertarian Cato Institute</u> that contends the legislation would not prevent parents from "double dipping" into another state voucher program, thereby increasing the burden on the state's finances.

Vouchers DO NOT help low income students attend private schools. Here is what really happens.

Let's say that an elite, private school costs \$15k per year to attend and the state grants a voucher worth \$10k for everyone to attend. What then happens the elite, private school raises its tuition to \$25k per year. That way they get the gov't \$10k plus the "market rate" of students willing to pay the original \$15k.
