Even before its release on June 9, a new book divulging exclusive behind-the-scenes details of Supreme Court Justice Brett Kavanaugh’s confirmation last year became Amazon’s No. 1 non-fiction bestseller.

Written by Federalist Senior Editor Mollie Hemingway and Judicial Crisis Network Policy Director Carrie Severino, “Justice on Trial: The Kavanaugh Confirmation and the Future of the Supreme Court” is rapidly gaining as the important American event’s first historical account.
