Wal-Mart creating jobs, encouraging competition

The contention supported by The News that the Western New York market cannot support any new retail business is deeply disappointing, statistically unfounded and sends the wrong message to the community and potential investors ("Wal-Mart's expansion heats up grocery wars," May 24).

Wal-Mart plans to create approximately 850 construction jobs and close to 2,000 full- and part-time associate positions over the next few years. We think competition is a good thing, because the consumer benefits by saving money. We are encouraged by the recent openings and/or expansions of the Walden Galleria and retailers such as Kohl's, Wegmans, Target, Metro Mattress, Price Rite, Christmas Tree Shops and others.

Gay marriage law won't threaten religious liberties

In a letter to the editor on May 27, a writer asserted that gay marriage will "imperil religious freedom or the rights of institutions or individuals to relate respectfully." He cited instances where businesses and religious institutions have been "marginalized, sued and forced to participate in practices that violate their consciences."

The writer fails to understand real respectful relations, and the limits of religious liberties and convictions. We are not so far from a time in our country when it would have been considered "morally objectionable" for a couple of different races to marry, and in that time these "threats to morality" were legislated against and used by businesses and religious institutions alike to cover what is today recognized as flagrant discriminatory practices.

In plain language, denying homosexuals access to the services of a business or institution on the grounds that they are homosexuals is simply not a religious liberty. It is a practice as sordidly discriminatory as denying access to Jews for being Jews, or heterosexuals for being heterosexuals. Will same-sex legislation threaten religious liberties? No. So long as we enjoy our liberties at the expense of others, we are just confusing liberty with oppressing those who make us uncomfortable.
