# Learning More About the New Law

## By DAVID M. HERSZENHORN

Now that Congress has adopted the big health care legislation, a lot of people are looking for more information about the bill in hopes of figuring out what it means for them, or how their members of Congress voted.

We'll be addressing <u>many of the issues confronting consumers in Tuesday's Science Times</u>. For more information on the political and social implications, start with the Prescriptions blog itself. There's a handy "search this blog" feature at the top right of our main page.

Looking back through our archives, for instance, you can find <u>a primer on health insurance exchanges</u>. (For an example of what an exchange might look like, <u>check out the Massachusetts version</u>.)

The New York Times Politics page lets you see <u>how individual representatives voted on the main health care bill</u> or <u>how they voted on the budget reconciliation bill containing the final revisions</u>.

There is also detailed information on the Senate's roll call vote on the reconciliation measure and on the vote on the original Senate bill on Dec. 24.

Elsewhere on the Web, the office of House Speaker Nancy Pelosi has posted <u>an overview of the legislation</u>. Keep in mind that this is material pulled together by the bill's main champion in Congress, so it presents the legislation in a positive light. And as Robert Pear reported in today's Times, there are already disputes about <u>how to interpret</u> <u>specific provisions in the legislation</u>.

Still, the speaker's site provides some helpful documents, including <u>a timeline for implementation of various</u> <u>provisions in the legislation (pdf)</u> as well as <u>a list of provisions that are supposed to provide immediate benefits (pdf)</u> within the next several months.

There are also documents aimed at highlighting portions of the bill of particular interest to different groups, including seniors (pdf), young Americans (pdf) and small business owners (pdf).

For a look at what Republicans were proposing on health, including comments by leading House Republicans on what they view as the way forward, visit <u>http://www.gop.gov/solutions/healthcare</u>.

The Senate Democratic Policy Committee also has <u>a site bulging with information</u>, including <u>section-by-section</u> <u>analyses of the main bill (pdf)</u> and <u>the final budget reconciliation bill (pdf)</u>.

The White House also offers <u>a health care policy section</u> on its site, including a selection called "<u>What will health</u> reform mean for you?"

For a rich trove of information about both the health care legislation and health care in America, <u>check out the Kaiser Family Foundation Web site</u>. Particularly helpful is <u>Kaiser's compendium of state-by-state data</u>.

All sorts of health care news and information can also be found on <u>The Health Care Blog</u>, which is focused largely on policy and the marketplace.

The new legislation will broadly expand Medicaid, the federal-state insurance program for low-income Americans, and will sustain C.H.I.P., the Children's Health Insurance Program, even after new insurance exchanges are up and running. A great clearinghouse of information about health care issues for children and families, especially for those eligible for Medicaid and/or C.H.I.P., is the <u>Center for Children and Families at Georgetown University</u> in Washington.

The Congressional Budget Office, which provides nonpartisan cost analyses for Congress, has <u>a health care page</u> where all of the various reports and cost projections on the health care legislation can be found.

The Cato Institute provides <u>analysis of health care issues from a right-leaning perspective</u>, while the <u>Center on</u> <u>Budget and Policy Priorities</u> provides analysis from a left-leaning perspective.

American's Health Insurance Plans, a main lobbying group for private insurance companies, offers <u>its perspective in</u> <u>blog format</u>, including skepticism about the legislation's ability to control health care inflation and slow the rise in health insurance premiums.

Going forward, a lot of the effort to put the new legislation in action will take place at the federal <u>Department of</u> <u>Health and Human Services</u>.
