## McCain Lieberman Bill Would Imprison US Citizens Indefinitely?

Via <u>The CATO Institute</u>. If this assertion proves out, tell me it isn't time for John McCain to go home and stay there. I figured maybe he's a touch senile, but this is just nuts. And what's Lieberman's excuse? I want to read more on this before drawing any conclusions.

As I wrote in this post, Senators McCain and Lieberman proposed a broad piece of anti-terrorism legislation. The Enemy Belligerent, Interrogation, Detention, and Prosecution Act of 2010 would use military detention to incapacitate suspected domestic terrorists, including American citizens. This is a sea change in counterterrorism policy and a break from American principles that mandate a day in court.

The kicker is that aliens detained domestically under this system must be tried by a military commission. Citizens cannot be tried by  $\underline{\text{military commissions}}$ , and the jurisdictional language in the Military Commissions Act (MCA) reflects this. Basically, the government would collect a bunch of intelligence that is inadmissible in federal courts and then hold American citizens indefinitely. Also, detaining large  $\underline{\text{numbers}}$  of Muslim aliens (who may have strong ties to local Muslim communities) and prosecuting them in military commissions threatens to radicalize citizens who are Muslims. The perceived double standard — commissions for Muslims in America, civilian trials for everyone else — is counterproductive when it comes to defeating terrorist recruiting.
