WASHINGTON — The Republican National Committee demanded a refund and launched an investigation Monday into how nearly \$2,000 from its campaign account was spent at a sex-themed nightclub in the Los Angeles area, an RNC spokesman said.

The committee's February report to the Federal Election Commission shows it paid \$1,946 on Feb. 4 for meals at Voyeur West Hollwood The club's website describes it as "a destination for provocative revelry that combines eroticism and nightlife exclusivity."

RNC spokesman Doug Heye said in an e-mail that the committee paid the reimbursement to Erik Brown, the head of a California marketing firm that has worked for GOP candidates. Heye said Brown would return the money to the

An RNC staffer, who accompanied a group of donors to the nightclub and filed the expense, has been fired by the committee, Politico reported. In an internal committee e-mail obtained by Politico, RNC chief of staff Ken McKay announced the termination of the staffer, who was not

Brown did not respond Monday to phone and e-mail messages left at his firm, Dynamic Marketing.

The payment was first reported Monday by The Daily Caller, a website founded by conservative commentators Tucker Carlson, who is also a senior fellow at the Cato Institute, and Neil Patel, who was an adviser to former vice president Dick

Heye said Republican Party Chairman Michael Steele had nothing to do with the bar tab. "This was a reimbursement made to a non-committee staffer," Heye's statement said. "The chairman was never at the location in question, he had no knowledge of the expenditure, nor does he find the use of committee funds at such a location at all acceptable."

A Los Angeles Times article about the club's opening in October describes Voyeur as "not a sex club but rather a high-end nightclub." Entertainment includes "impromptu bondage and S&M'scenes' being played out ... by scantily clad performers."
