Carte's Votes: Hoppy's Commentary

Carte Goodwin, West Virginia's newest U.S. Senator, will be sworn in Tuesday and given barely enough time to learn the location of the Senate bathroom before he has to vote on important legislation.

The first comes shortly after he takes office today (Tuesday): a vote whether to continue the extension of unemployment benefits for nearly two years. Jobless benefits are normally 26 weeks, but they have been extended to 99 weeks because of the recession.

Democrats, urged on by President Obama, want the extension to continue, using \$34 billion in borrowed money to pay for them. Republicans want half of the money to come from the unspent stimulus.

Goodwin is expected to provide the 60th vote necessary to block a Republican filibuster. That vote will likely play well back home in West Virginia because of a lackluster economy and high unemployment, but it's lousy economics.

Borrowing \$34 billion adds to the ballooning deficit and creates a disincentive for work. "Workers are less likely to look for work, or accept less-than-ideal jobs, as long as they are protected from the full consequences of being unemployed," Michael Tanner, a senior fellow at the libertarian Cato Institute, told the Washington Post.

In addition, Washington's out-of-control spending will not be Goodwin's concern. He's not running for the seat and his term as "Senator-till-November" will long be over before the full consequences of Washington's profligate spending are realized.

Then Goodwin will have to vote whether to approve another \$40 billion in emergency war funding, mostly to pay for the surge of 30,000 additional troops in Afghanistan. The House of Representatives has tacked another \$23 billion in stimulus spending to the war funding bill.

The question for Goodwin will be whether he wants a "clean" bill that only includes money for the ongoing fights overseas or whether he supports legislation that includes even more domestic spending.

One way or another the bill is going to pass, otherwise the military will have to begin an immediate drawdown in Afghanistan.

Finally, and most critically in the early days of Goodwin's brief tenure, will be his support or opposition to an energy bill.

Senate Majority Leader Harry Reid is making one last effort before the August recess to

pass legislation that will include caps on carbon emissions that target coal-fired power plants. The legislation would ruin West Virginia's economy which depends heavily on coal.

West Virginia needs a "no" vote from Goodwin—and, of course, Sen. Rockefeller as well—to protect a vital part of West Virginia's economy. Politically, a "yes" vote by Goodwin on the energy bill would damage Gov. Manchin who is responsible for Goodwin being in Washington.

Under different circumstances Carte Goodwin would have been able to go to Washington, hang a few pictures on the wall, try out a bowl of the famous bean soup that's on the Senate restaurant menu every day and get adjusted to the new digs before delving into weighty matters. Instead, he's been tossed into the maelstrom of Congress with important issues hanging.

And West Virginia is watching.
